# REPORT OF NATIONAL DIRECTOR

# 2017 - 2018

## B. L. Bhattacharyya

New Members may not be aware of the fact that The Theosophical Society was founded at a time (1875) when slavery was common in many parts of the world, when invasion of a country by another was considered to be normal, when religious hatred and the violent clash of materialism against religions were frequent, when women, youngsters and children were considered to be on an interior level, when there was discrimination among races and ethnic groups as well as other negative barriers and misconceptions. There were no plane cars, telephones, electricity, radio, television or computers at that time and the UNO had not been created either.

Madame H. P. Blavatsky remained busy in writing books namely "Isis Unveiled", Secret Doctrine "Key to Theosophy" voice a silence etc. and in touring with Col. H.S. Olcott to establish branches of TS in different parts of the world. Both of them worked and sacrificed their lives for the benefit of the Humanity.

Dr. Annie Besant became the 2<sup>rd</sup> International President of TS in 1907 and founded the Theosophical order of Service in February, 1908 with the Motto – 'A Union of all who love in the service of all that suffer and the main object was to make the first object of TS practical. The scenario of the world has changed. Most of the countries are free, resources have increased but sufferings of men, women and animals are very much there. In order to satisfy the greed of human beings they themselves have created their own graves. There are adulteration of food, Pollution in environment. Corruptions and torture on women are the daily news of the papers. Brotherhood of humanity has not yet been fully established. India is a country more than 120 crores of population, 25% of which are still below poverty line.

TOS-in India with 22 regions, more than 100 active TOS groups and good number of life and patron members did well during 2017-2018. Activities of the regions appear in this book separately. I would like to mention some events only.

TOS Camp: TOS Camp was organized at the Himalayan study centre of TS at Bhowali on 29-31 May, 2018 with Sis Nancy Secrest International Secretary of TOS, Sis DeepaPadhi International Vice-President and Sis MarjaArtamaa, International Secretary of TS with 30 devoted Members from different regions of India. The theme of the camp was—"working towards future". Detailed news were published in Indian Theosophist—August, 2018 issue. It was a very successful camp with illuminative presentations of participants which I missed due to unavoidable reasons. I must thank Bro. K. Sivaprasad, Secretary and Bro. V. Narayanan, Treasurer of TOS in India for their efforts to organize the camp satisfactorily.

### 2.a) Zonal Conference:

All the 4 Zonal Conferences were organized successfully during, 2018.

East Zone TS / TOS Conference was organized on 24-25 February, 2018 at BTS Hall, Kolkata with Bro. Pradeep H. Gohil. General Secretary, Indian Section of TS as Chief Guest and Bro. B. L. Bhattacharyya, Dr. ChittaranjanSatapathy, former International Vice-President of TS, Bro. K. Sivaprasad, Secretary, TOS in India as Guest Speakers. The main theme of the conference was "reality lies within". There were 110 registered participants. Bro. Pankaj Kumar Dutta, President BTF was on the Chair. HemenduBikashChowdhury. President BTS welcomed all the guests and delegates most warmly. On 2nd day Bro. Shaikh Md. Zaki, President TOS West Bengal presided over the function with other guests of the conference including Bro. PrahladDebnath in-charge of TOS in Bangladesh and Dr. Almas Rahman who expressed their views on the subject. Service without expectation helps individual to grow inwardly. 30 teachers of 4 TOS schools were awarded for their service with love and compassion. Cheques for Rs.1,20,000 were given to TOS groups for orphanage and school. There was a cultural programme directed by Sis MadhusriChowdhury. A souvenir was published to commemorate the EZ, conference 2018.

- b) The South Zone TOS conference 2018 was held at Adyar on 24-25 March, with the theme "service through will, wisdom and love". It was inaugurated by Sis Nancy Secrest International Secretary of TOS. Sis MarjaArtamaa International Secretary of TS was the chief guest. Both of them as well as Bro. K. Sivaprasad National Secretary of TOS-in India addressed the gathering. After lunch session was devoted to Presentation of TOS activities by various regional groups. The conference concluded with a valedictory address by Bro. S.HariharaRaghavan followed by a vote of thanks by Dr. R. Revathy. It was a successful conference news of which were published in May, 2018 issue of the Theosophist with group photo.
- c) North Zone conference was held on 4-5 May, 2018 at Delhi TS Federation Hall with Bro. B. L. Bhattacharyya as Chief Guest and Sis Uma Bhattacharyya, Joint Secretary of TOS-In India was the Key Note speaker in the Conference Dr. T. K. Nair, former National Secretary of TOS-In India was the Special Guest. The theme of the conference was "Service A. Journey from contact to connection". Sis VibhaSaksena, President TOS Delhi region welcomed the guests and audience most warmly. Bro. M. L. Khetri, Bro. Col. B. K. Kailash, Bro. V. K. Taneja, Bro. Hement Sharma, Bro. J. K. Khana spoke on TOS related subjects. The second day of the conference started with TOS-Geet by children of prayas

TOS group and dance performances of unprivileged children of other groups. There was a session for presentation of TOS activities. Dr. D. K. Satsangi president of TS Delhi Federation in his short and illuminative talk appreciated the work of TOS groups. The meeting concluded with vote of thanks by Sis SuvralinaMohanti, Regional Secretary who revived TOS – Delhi Region two years back.

d) West Zone TOS Conference was held on 8-9 September, 2018 at Jaipur in Rajasthan with our beloved International Secretary, Sis Nancy Secrest as Chief Guest and Bro. K. Sivaprasad, National Secretary of TOS-in India as special Guest. Since it was TS / TOS Zonal Conference and Bro. Dr. M. P. Kol.Bhandari, founder President of Jaipur TOS Group and Rajasthan Region who was working with a team of dedicated workers, excellent arrangement was made for accommodation and presentation of President & Secretaries of other Federations and Regions within the zone. A souvenir was published to commemorate this occasion. It was a very successful programme. Detailed news will appear separately in this book.

### 3. Regional Conferences:

Most of the TOS regions organized their annual conferences on different dates during 2017-2018. Odisha TOS Region organized it's annual conference on 23rd September, 2018 with His Excellency Hon'ble Governor of Odisha as Chief Guest and Bro. K. Sivaprasad, Nation Secretary of TOS in India as Guest of Honour. I attended the regional conference of TOS West Bengal held on 30th September, 2018 at BTS Hall with Justice ShyamalSen former Governor of West Bengal. 52 teachers of 6 schools run by TOS groups were felicitated and awarded for their service with love and compassion to students. Both the conferences were successful.

## International Women Day :

TOS Odisha region extended warmed felicitation to Smt. DroupadiMurmu, honourable Governor of Jharkhand on the occasion of International Women's Day, 8th March, 2018 for her excellent contribution in the field of education administration, women empowerment and above all her ideal living.

## 1. Permanent Projects:

We have been encouraging / helping permanent projects run by different TOS Groups. I am delighted to report that we have 6 Primary Schools, 2 orphanages, 4 Tailoring training centre, 2 computer centres in West Bengal, 2 primary Schools and other projects in Odisha, two schools and other projects in U.P. East and U.P. West, one school for street children at Assam and one hostel for blinds students at Bihar, one primary school at Uttarkhand and one Primary School at Kashmir. Bombay TOS – Region has sponsorship project for more than 520 poor students. It's member have donated more than Rs.1,50,000/- for Kerala Flood Relief Work. We hope, other TOS regions will try to have at least one permanent project run by any of their TOS Group.

### 2. Visits:

Regional Secretaries visited their TOS Groups. National Director, National Secretary, Joint Secretary, Treasurer and former National Secretary of TOS- in India attended TOS Camp, Zonal Conferences Regional Conferences and other programmes different TOS Groups. Our beloved International Secretary of TOS and TS and International Vice-President of TS also inspired our workers by visiting TOS Programmes.

 Karnataka TOS Region did excellent work during this year. They organized quarterly service programmes and distributed thousand of study materials to poor students. They collect Rs.3 to Rs.4 lakhs from their members every year for their TOS activities. Maharastra, Rayalaseema, U.P. (East), U.P. (West), Chennai, Delhi, Telegu and Tamil Nadu Regions did well. Hariyana, M.P., Chhatisgarh and Kerala Regions need attention and help for revival.

4. Bro. Altaf Lone, Secretary, SADA – E Kashmir TOS Group inspite of Problems in the Valley did very good work, organized medical camp on 19th April, with good number of doctors and community people, awareness camp for clearness and good health. On 24th January, 2018 they organized sports event to bring the youths on disciplined platform which was very effective. They also conducted painting and art workshop for school going students and Brest feeding programme to provide nutrial diet which helps newly born babies to grow. Many congratulations to Bro. Altaf and his team for their innovative programmes.

# PERIOD OF REPORT:- Oct,2017-Sept 2018

- 1.A charitable Homeopathic Dispensary is working daily for two hours in the evening [from 5:00 pm to 7:00 pm] except Sunday since 1996 and average no. of patients ranges from 10 to 15.
- 2.One allopathic Physician devotes two hours time on every Monday, Tuesday and Friday attending patients free of cost.
- 3.All the equipments for eye testing have been purchased for starting free eye-check-up programme.On Tuesday and Thursday one eye specialist and one dentist render their services free of cost for two hours.
- 4. Wednesday is utilized by an acupressure doctor with his one lady assistant for about four hours. The average no. of patients is about 20.
- 5. One gynecologist lady doctor is available on call free of cost on every working day.
- 6. We are providing clinical check-up at 50% cost only.
- 7. About 100 saplings have been planted in a local College premises.
- 8, Fifty blankets have been distributed among the old and poor people in a local village about 30 kilometer away from the town.

Career – counseling & free coaching for students of 10th class of Gyan Deep Public School, Samastipur was organized in the month of January`18

Awareness programme for different dental diseases was organized in first week of February-2018.

Free dental checkup & awareness programme was organized by Dr. Charvee in Oasis Public School, Mathurapur, Samastipur under T.O.S., Samastipur Group of Bihar Region on 19th April`18.Dr. Charvee is Life member of TS & TOS from Samastipur, Bihar. She is Ex-Executive Member of Bihar Theosophical Federation & is very much interested in social service. Special thanks to Md. Masi Ahmed, Director of Oasis Public School for his co-operation in this work. He is also a life member of TOS, Samastipur Group 3. Chhapra

It runs a Blind School with a hostel.

It runs a charitable homeopathic clinic to treat an average of 25 patients per day.

Cold water is provided during summer.

Heating arrangement is made available at several places during the winter season.

A sum of Rs. 2000/= was donated to a poor patient.

It runs a Montessori School[Bal Bihar]in TS campus for welfare of poor children.

# REPORT of ACTIVITIES in MAHARASHTRA region (2017-18)

A. Permanent activities:

1. Supplying school materials to poor students of primary schools in villages in Pune district:

Since 2010, the students of 7 primary schools learning in remote places and villages near Pune are being suppliedby school materials (notebooks, drawing books, pencils, rubber, crayons, slates and useful books). The beneficiaries to the tune of about 100 students every year belong to poor families which may not otherwise afford to buy such materials. The intention of the activity is to encourage the students for studies. In order to support in their overall development, the elocution competitions of primary school students have been arranged regularly. The teachers in these schools are well versed with theosophical teaching.

# 2. Honoring social workers for their contribution in the service to humanity:

The social workers in different districts where the are identified and are invited to get honored. A shawl, souvenir, certificate of honor and set of books of theosophy are given to the honored person. - 3. Kakinada Group of TOS can proudly inform that the benevolent charity program of an organization Chirudeepam, a Registered Society comprising likeminded employees of Reliance Industries Limited. # Report of The South Zone T.O.S. Conference.

The Theosophical Order of Service (TOS) in India had is South Zone Conference (SZC) at Adyar during 24-25 March 2018, themed 'Service through Will, Wisdom, and Love'. It was inaugurated by Ms Nancy Secrest, international Secretary of the TOS and international Treasurer of the TS. Ms Marja Artamaa, international Secretary of the TS was the Chief Guest. The next day, a few non-governmental organizations (NGOs) talked about their work in helping underprivileged people.

Two of the NGOs are doing remarkable work. One of them collects used clothes in good condition, gets them cleaned and ironed, and displays them with price tags, similar to a shop. They also distribute free coupons to needy students in the nearby schools. The students with their family, then choose the clothes needed by them and pay with the coupons. Another NGO works with children who do well in studies but do not have the means to go to college. The group has an arrangement with a few colleges who offer a few free seats in exchange for services provided by the members of the NGO in imparting job training to their graduating students. Both the colleges and the underprivileged students are benefited by this arrangement. The remarkable thing about these activities is that there is no 'charity' offered and the recipients of the service retain their dignity; there is no money involved anywhere in the process, hence it is less likely to become corrupted; and the recipients themselves feel empowered and are verylikely, in turn, to help others who are needy, thus helping to perpetuate the work.

The presentations were followed by a visit to the TOS medical camp and an audiovisual presentation on 'Selfless Service'. The programme concluded with a valedictory address by Mr S. Harihara Raghavan, followed by a vote of thanks by Fr. R. Revathy, Convener of the meet and Secretary of TOS. Adyar.

# REGIONAL CONFERENCE GUIDELINES

- The Region should organize Annual General Body Meeting and Annual Conferences within September every year with a chief guest as National Director/Secretary/National Committee member and a report to be sent to the Secretary, TOS India. If so desired the AGM and AC may be clubbed together.
- Officers to the Region should be elected in the A G M after giving due notice to all good standing members after every three years. In case the Region fails to do so, the president of the region should suggest to the National Director the name of the person to be appointed as Regional Secretary to form a new Executive Committee for their Region.
- The Annual report, and audited account of the Region along with the enclosures are to be sent to TOS India duly approved by the AGM.

# GUIDELINE FOR COLLECTION OF DONATION FOR TOS WORK

B. L. Bhattacharya, National Director

Members of TOS should remember that it is not an organisation like other NGOs who also render service to minimise the suffering of others, collect money from many sources and utilise a portion of it for staff salary and other administrative cost.

TOS is a union of all who love in the service of all that suffers. It has great significance. It is a service with love and regards and without any expectation to all living beings.

TOS groups are mainly formed by TS members and its activities make the first objective of TS practical and they carry the message of TS to common people to some extent. Money and dedicated works are needed to render proper service of course, there are many ways of helping the needy without money also. Charity should begin at home.

Presidents, Secretaries of groups and regions and kind hearted members donate for the work of TOS. If the group or region is properly organised they can collect donations selectively from corporate sector and banks that provide funds for social work. For this purpose they need to maintain and submit audited account, article of association, PAN card etc but they are not required to get the TOS group or region registered separately as TOS. India (1908) is registered under the registration of societies Act 1860.

If the donors want to avail of the benefit under 80(g) of the income Tax Act 1961 then at par cheques or drafts in favour of theosophical order of service in India payable at Varanasi to be collected and sent to National treasurer, TOS India, Varanasi to issue necessary certificate and remittance of fund to respective groups and region.

Proper project on health education sanitation, drinking water,

animal welfare and environment etc should be sent along with the appeal for donations. While collecting donations, TOS groups and Region should consider the motive and honesty of the donor. The donations should be utilised only for the purpose for which it was paid.

# The Theosophical Order of Service.

An Address by Dr. Annie Besant

THE THEOSOPHICAL ORDER OF SERVICE was founded in order that a definite line of work be done on the ground of Brotherhood used in Service, and for that reason it requires a certain number of members to be connected with the T. S.

At one time, there was an inclination to confine the work of the T.S. to Theosophical Teachings. If we use the translation of the Greek word Theosophy, Divine Wisdom, there would be no danger of the T. S. being a sect.

The T. O. S. must leave the people free to show their brotherhood, to choose their own line of work. The term "Theosophical" Order of Service emphasizes the fact that the theory of brotherhood is embraced by its members, the same as tolerance and a willingness to accept all forms of Truth. "There is no Religion higher than Truth". The brotherhood of the T. S. is a nucleus of brotherhood. The O of S is intended to help us towards the realisation of Universal Brotherhood, not merely a brotherhood of the Elder Brothers, but with the criminal classes as well. Universal Brotherhood must not be a phrase, but a principle in life.

Is the first object of the T. S. in conflict with the second and third? If we talk of Universal Brotherhood, we ought to make no distinction as to who should be admitted to the Society. I should like to include in Universal Brotherhood, not only humanity, but all animals, even plants and minerals. We have a particular cell from which all the formative powers, strength and life go out. By treating a dog kindly, his mental growth quickens. A master said: "The heart of our Brotherhood is the unselfish service of mankind." That should be the aim of every

member of the O. of S.., should be an active force with which every member takes up some duty of a beneficent kind. A certain no-Theosophist, who is a keen worker, asked for a group in favour of vivisection to be formed in the O. of S. as a group for anti-vivisection already existed. I told her that, if she could show that torture of animals was consistent with brotherhood, I should agree. I never heard of the matter again.

Let us not fear to go among the lowest; for the purer the person, the more can be move in perfect safety, even among the most "Vile". When Shri Rama, the perfect king, was approached by a woman of bad reputation, he accepted the gift she offered and ate the fruit she had bitten into. And the Christ, when giving back health to the diseased, told them to "sin no more", to live the perfect life, the seed of which is in everyone and everything. There is only one Divine Life, and all life is part of Him. "Shall there be evil in a city, the Lord hath done it." "If I go up into Heaven, Thou art there, if I go down into Hell. Thou art there also."Reverence the Divine Life in everything; recognize that good and evil are experiences. The more experiences we have, the better we evolve. A "mistake" as Mr. Ford once said, is but what adds to our knowledge. We should of right or wrong by the person who does it; thus we shall know whether it was done willfully or as a mistake. As imperfect beings, we cannot do perfect work, but we can realise that gaining an experience is the only way to progress.

Consider a discovery such as that of Galvani, the great investigator, who found the action of Galvanism through his observation of the moving frogs' leg hung on his balcony. Let his friends call him the "Frogs' dancing master"; he knew he had discovered a hitherto unknown law in nature. Thus our knowledge is ever increased. The Galvanometer, when put

on the head of a person thinking hard, answers by swinging. By looking into the unknown we progress.

If we take Theosophical thought as the key in our studies, we realize that God exists everywhere, that He who is Supreme Goodness, is also Supreme Law. Our understanding increases with our learning:"Give me understanding and I shall keep your Law, yeh, I shall keep it with my whole heart."

Reincarnation is the key to the world. The more we study Theosophy the more will the puzzles of the world become clear.

In the O. of S. you have the key to an orderly life. Choose your activity carefully. In the morning make a plan of your day's work; use your thought power beneficially; make the habit (till it comes naturally) of snatching every opportunity to help and you will find thousands of things come in your way.

Do not get discouraged if your progress is but slow. I used to have a hasty temper, it took me years to get over it. I was helped by a lesson I got. I once saw a cartman striking the horse on the nose; I spoke to him heatedly and got a bad reply. Then I puzzled out that he was irritable only as I had been! I realized that in order to be truly useful, we must not stoop down, but must place ourselves beside those we want to help.

Try to bring into your Lodges people with whom you utterly disagree, and try to grasp their line of thought. The Law of Love, the only great law, will help you to understand the others; your knowledge will help you to bring the ignorant out of their ignorance and so to grow more quickly in evolution.

# TOS camp at Bhowali 29-31 May 2018

# First Day 29th Tuesday

Bhowali a beautiful small hill station located in Kumaon Hills of Himalayas at a height of 5426 feet above mean Sea level. It is in Nainital District of Uttarakhand state with many lakes attract tourists. In response to the announcement of the Indian Section, Theosophical Society, this camp was held at The Himalayan Centre in which 36 delegates participated.

Active TOS members from different regions of India participated in the event. It was a good gathering including Deepa Padhi, International Vice President, Nancy Secrest, International Secretary TOS, Marja Artamaa, International Secretary TS along with Adyar members Dr. Revathy and Sr. Sudha. From Varanasi Br. Narayanan, National treasurer participated and taken care of the entire programme from beginning to the end and all the members participated expressed sincere thanks for his kind hearted support.

The theme of the camp was "Working towards Future". Meeting started with Universal Prayer and followed by the welcome by Br.Sivaprasad, National Secretary,TOS india expressed gratitude for all gathered to attend this TOS camp. He read out kind and encouraging messages from Tim Boyd,International President,Br.Bhattachrya, TOS National Director,Br.Pradeep Gohil, General Secretary, Freny Toddywala (Mumbai),Adyar lodge,Telugu region,Karnataka region.

Before starting of inauguration of the camp we have shared the sad news about the demise of Sr.Kusum Sathpathy, w/o Br.Chittaranjan Sathpathy (former International Vice President). Sr.Deepa Padhi shared about

this sudden shocking news of the dedicated Theosophist who served as former International Secretary and did self less service for the Adyar development. All delegates observed silence for the peaceful journey of the departed soul.

In the inaugural address Sr.Deepa padhi emphasised that "You need to give more service." Service is really a journey of awakening because by rendering service to all forms of life, human and non-humans, one realizes the Unity of beings gets connected to the source". The theme" Working towards Future", refers to a process, a transformative journey through service. Service changes people.It refines, purifies, gives the best in every individual and importantly prepares to realize the oneness of being. While defining Theosophical Education, our International President Tim Boyd says-'It is an act of skill, science, art and wisdom'. He further says, 'Let our educational motive be to create the environments in which our students can experiencethefreedom, co-operation, strength, honesty, happiness and responsibility that are the birthright of every soul that comes into this world.'

At this point of time, TOS needs more willing hands more caring hearts and more intelligent minds to move our work towards future. The theme suggests optimism, dynamism and vision. It is said, 'Vision without action is a day-dream and action without vision is nightmare; vision and action together bring hope for the future."Future' is contained in the womb of 'now' in the form of experiences of the past and potentialities of the present. Working for future is the process of actualization of these potentialities. The outer requirements of any act of service include 1)selecting a genuine cause 2)identifying the target group or the beneficiaries 3) planning a budget and arranging funds 4) organizing human resources etc. But the inner equipments are most important which refer to will, pure motive, selflessness, empathy, strong

compassion, commitment and involvement. These are very much necessary for working towards a sustainable future. Sr.Nancy Secrest gave detailed picture of theosophical efforts in support of education from the time of TS founders. Children to be nourished with right kind of education for free thought, values, self reliance and to lead a whole life (not for job alone). Col.Olcott started with 45 children from downtrodden at Adyar and it is serving the poor local communities even today expanding in to high school and also branches in Kodambakam, Mylapore and Besant School. Theosophical educational trust was formed in 1913. Col.Olcott started many schools in Srilanka. Home schools and Nursing scholarships in Pakistan supported by Australian and American Sections were of significant contribution for the upliftment of women.TS invited for the stay of Maria Montessori in India at Advar where the unique child centred education was propagated and TS gave awards for her contribution during World War II. Evolution of Golden Link School and college in Philippines is an excellent effort to inculcate universal values and right kind of teaching for the overall growth of learner. Theosophical education emphasises on how to think but not what to think.

Sr.Marja Artamaa spoke about the Finland section TOs support for Adyar Olcott school. She expressed that in each individual there is compassion, ToS is an avenue for Theosophical living.TOS can work for some of the public concerns where TS may not be able to intervene. Explained the connectivity of TS and TOS and how both complement each other in spreading theosophy.

Br.Narayanan extended warm welcome to all the delegates for attending this TOS camp.In the charity people may feel that they are giving but it is also important to observe the opportunity provided by the served community. As treasurer of TOS in India he is in a position to guide financial regulations applicable to the charitable organisations to be followed by the branch offices.

Br.Basavaraja Reddy enlightened the delegates with the topic spiritual evolution and Service. He gave detailed speech on how individualisation of soul takes place from the divine spark in the journey of human evolution. Moving our attention from lower self to the higher self we will be undertaking service actions for the welfare of humanity rather than self centred attitude. We have a tendency to grow horizontally with materialistic desires and that has to be converted in to vertical level with spiritual growth. Personality development is centred around selfishness where as spiritual development is towards unselfish growth. The process of personality growth is a trial and error approach, the lower triad involved in worldly desires transforms in to higher triad with tolerance, compassion and unselfishness. Service is one of the channels for this transformation.

Before breaking for lunch we had the opportunity to view the video lecture shared by Br.Luke Michael Ironside from Philippines on the topic "Universal Brotherhood Practice".

In the afternoon Prof.Lambodar from Varanasi gave the importance of Art and craft along with demonstration. He studied in Rabindranath Tagore's Shanthinikethan in West Bengal. The need for art and craft is increasingly necessary in the modern way of fast life not able to appreciate the beauty of art. There is no need of sophisticated things required for this and demonstration was given on with simple materials available locally such as red soil or Rangoli powder can be used to draw nice pictures in front of the houses and during functions. Demonstration was also given on making of forms made out of paper cuttings. In Indian traditional art and craft many natural designs are existing which can lead for creativity and there is need for time and appreciation to get peace and harmony in life.

In the next session Sr.Nancy presented the PPt presentation on the past and future scenario in the progress of TOS. Participants were fortunate to view the glimpse of International programmes of TOS happening in various countries. This historical events of TOS from Annie Besant time up till now gave over view work of the ToS which was informative and inspiring with valuable pictures and messages.

### Second day 30th Wednesday

In the first session representatives attending the camp from the regions of Tamilnadu, Maharastra, Uttar Pradesh (East), Chenai, Telgu, Royalseema, Orrisa, Noida, Rajesthan and Karnataka presented their respective action Plan for the Next Five years (2018-2022). The need for revival of dormant TS and TOS lodges/Groups has been highlighted to consider as important intervention. Regular service activities such as tailoring machines support,Note books for poor children, Medical Aid,school fee payment for poor,Wheel chairs, artificial legs,and other various support activities as per the local needs are proposed in the future action plan. Special focus was on strengthening existing Theosophical schools and initiate new schools as priority work of TOS considering the need for primary education to the deprived communities.

In the next session brief talks on TOS related subjects were given by Col.Kailash, Br.A.P.Lokhande, Dr.Revathy, Br.B.L.Kandoi, Br.Pradip Mahapatra and Mithalini. Speakers shared various Service related matters with their practical experience in the field. Besides poverty, Compassion, Education, Health concerns it was also on the degradation of environment/ Ecological destruction which is a serious issue linked with poverty among poorer sections of society.

After Noon session was on "Past Life Regression Therapy" by Sr.Lipa Rath whose Grand Father Late Dr.Ramachandra Rath was founder of Theosophical Society in Odisha. This technique of past life regression is based

on QHHT (Quantum Healing Hypnosis Technique) founded by Doleres Cannon in America. It was an interesting session to know how this technique is beneficial for the acute health issues of psychological, physical and other mental ailments.

In the evening cultural event was an entertainment time with dance, Music and songs performance by local ' Kumaon cultural Association'. All the participants were happy to see this local traditional folk dances of this region.

# Third Day Thursday

In the morning session Sr.Deepa Padhi held interactive discussion on practical implications TOS. In this crucial matters related to TOS programmes need, process of implementation and the cooperation extended by members were discussed thoroughly. During this interactive dialogue session challenges faced by TOS as an institution was dealt with, major concerns include lack of active members, funds, leaders, ideas and motivation. Some of best examples of success in TOs actions were narrated by members. It was informed that in the month of November 2018 there will be two days TOS teachers training programme being organised at Indian section, Varanasi with the guidance of Br. Vicente Hao Chin from Philippines. Schools run by theosophical societies in India will be communicated about this for their teachers participation. Br.Narayanan gave the financial details as per the Indian law regarding obligations under Income tax, service tax and the registration norms to be followed as non profit bodies. In the last session Br. Sivaprasad presented the Action plan for the next five years. All the delegates gave valuable inputs to make the list of interventions at Group level, regional, National and at all levels. Following is the list of activities:

## Group level

- 5.Explore CSR (corporate social responsibility) funds for TOS

#### National level

- 1.Preparation of Theosophy study material for including in the curriculum of school/college
- 2.Coordination with United nations bodies.
- Creation of funds for Fellowships to undertake deeper Theosophical studies
- 4. Formation of new groups and revival of Lodges
- 5.Coordination with International TOS for collaborative programmes

- Conceptualising for establishing a Theosophical University in India
- 7.Preparation of permanent projects and mobilise funds. At all levels (Group, Regional and National)
- 1.Observation of auspicious days like Adyar day, White lotus day, AB birth day etc.
- 2.To include spiritual dimension rather than only charitable activities such as:
- a) comforting the bereaved
- b)caring elders
- c)Advising parents with difficult children
- d) awareness on climate change/cruelty in factory farming/ Farmers suicide/distress migration

The three day camp concluded with the encouraging feed back from the participants. It was emphasised the need for strengthening TOS as an Institution working actively at Group, regional and national level. There are more than 6000 patron/life members of TOS and their involvement at present is confined to membership fee payment only, where as it is suggested that their participation in activities of service will be more meaningful. Hence there is need to form a network of them for greater strength of TOS. It was observed that indiatos.org web site may be more actively used for sharing information and reports. It was acknowledged that International tos web site is very much resourceful with valuable information related to TOS for ready reference. All the members attended expressed the usefulness of this camp and suggested for further improvement in future. Local delegates Br.Sanit Joshi and other office bearers of Bhowali TOS group which was formed recently received Diplomas from Sr.Nancy, Br.Sanit Joshi appreciated the camp and requested for more activities in the Himalayan centre.
