# **REPORT OF NATIONAL DIRECTOR**

**2018-2019**

**B.L. Bhattacharyya**

Happy New Year 2020 to you all, brothers and sisters present here. Most of us know that Dr. Annie Besant was a noble Lady with extra ordinary qualities. She came to India in 1893 to learn from the pious land of the Great Masters. But she saw that Indian had forgotten their glorious tradition and teachings of their forefathers. Then she took the role of teacher, travelled all over India and awakened the sleeping nation. Dr. Besant established about 200 schools, wrote 300 books. Her contribution in Indian freedom struggle and Theosophical Movement around the world cannot be forgotten. Membership of TS during her time was highest. She became the International President after Col H.S. Olcott in 1907 and established the Theosophical Order of Service in February 1908 with the object to minimize the suffering of all living beings.

In India TOS was formally established in 1976 and registered in 1977-78 as Charitable Society with it's Head Quarter at Indian Section of TS. Kamachha, Varanasi with main object: To make Brotherhood real and practical so that misery, ignorance and pain may visibly diminish and the world become a happier place for all living beings. TOS India has it's constitution.

India has 130 crores population one fourth of which are living below poverty line. News of kidnapping innocent girls, violence of women, exploitation of child labours in different industries, in dhabas, restaurant, hotel etc. frequently appear in daily papers women are not safe in our Nation Capital too, for which Delhi Govt. had to engage on 30.10.2019 about 34000 Bus Marshall to safeguard the violence on women in Bus journey. We therefore considered "Empowerment of Women" as our National Project and requested all TOS-Regions in India to work for the education of poor students to prevent dropout from school and to open Primary Schools in remote villages and slum areas. I am glad to inform you that TOS-Regions in India did good work during 2018- 2019 details of which appear in this book separately.

During last 16 years I had the opportunity to visit many TOS Groups in India and observed that quality and quantity of TOS work mainly depends on the devotion and dedication of Group-leader, his capacity to inspire other members. It was an unique experience for me to visit a school at

Kashmir with Dr. T.K. Nair and to meet Bro Altaf Lone. The school is situated in a remote village about 50 KM far of from Srinagar. Subsequently Bro Altaf has formed a TOS-Group and is working for the welfare of children and women. I visited Mahabharat TOS Group of Bhubaneswar founded by Dr. Deepa Padhi on different occasions. She has been doing excellent work in the fields of education of poor students and "Women Empowerment". They observed International Women Day on 8th March 2018 award\*her excellence Hon'ble Governor of Jharkhand Smt. Droupadi Murmu in a meeting. A Special Bulletin titled "Empower Yourself" was published to commemorate this occasion. 6th TOS-Regional Conference, Odisha 2019 was held on 22.09.2019 in the Royal College of Science and Technology, Bhubaneswar with Prof. Ganeshi Lal, Hon'ble Governor of Odisha as Chief Guest. Theme of the conference was "Transform the self; Transform the World". More than 500 Members, Students and beneficiaries were present in the programme. Dr. Deepa Padhi's leadership and contributions in the field of TS & TOS have made her known and popular in the Theosophical world. She is now President of TOS-Odisha Region and International Vice- President of The Theosophical Society.

Shaikh Md. Zaki, and Bro Gangaram Hazra, President & Secretary of West Bengal TOS-Region are also doing good work. They are running 10 Primary Schools in need based areas, two orphanages and 6 Tailoring Training Centres particularly for the earning of poor women. Sis Freney Toddywalla of Mumbai Region not only retained all the projects introduced by Late Bro Russy Toddywala but could inspire the Members to donate liberally for flood affected victims of Kerala & Odisha. Mumbai Region organized its Annual colloquium at Leslie Sawhny Centre Deolali 26 to 30 October 2019 with the theme - "If you ever need a helping hand, you'll find one at the end of your arm". It was a successful programme.

Late Bro J.N. Patowary was a dedicated TOS-worker. After him Assam Region has become weak. However they organized two livestock camps during this year. Bihar is running hostel and a school for blind students. Regional Secretary Dr. Rajkishore Prasad has revived the activities of its Groups. Dr. R. Ravathi, Secretary, Chennai Region is doing excellent work with the help of other doctors. Sis Vibha Saxena and Sis Suvralina Mohanty of Delhi Region are working for the welfare of children and young girls. Bro Kanti Bhai Patel was very active. He took me to different TOS-Groups in Gujarat. He had a heart surgery last year for which TOS activities became slow in Gujarat. Karnataka TOS Region is doing excellent work in the field of education of poor students. They organized 4 quarterly service programmes at Bangalore and distributed money and materials to needy

persons. They have highest number of active groups and dedicated workers like Bro C.N.S. Setty, Bro K.V.K. Setty, Bro Sanat Kumar and Bro S.U. Mahesh and others.

A new TOS Group with English Medium Primary School has been formed in Kerala and dedicated TOS & TS workers including Dr. M.A. Reveendran, Bro K. Dinakaran, Bro Edwin Fernandez worked hard to distribute relief materials among the victims affected by unprecedented flood during this year. Bro Sanjay D. Potey, President of Maharashtra TOS Region is a devoted worker. Under his leadership TOS-Maharashtra Region is running a English Medium Primary School at Akola and most of their groups are active. Dr.M.P. Kolbhandari of Jaipur and Dr. Kamal Mahnot of Jodpur are very devoted TS/TOS workers. They are working in the field of Health and Education. Rayalaseema, Tamil Nadu and Telegu Regions are doing very good work. Dr. Kumud Ranjan, Secretary UP(East) and Col.B.K. Kailash, Secretary UP (West) are running different projects on poor girls and phycally handicapped persons. We could form more than one TOS Group at Uttarakhand. Bro S. Joshi of Bhawali is trying to increase TOS activities in this Region.

News of TOS activities and TOS conferences were published in Indian Theosophist for which I am obliged to the President of Indian Section of TS Bro Pradeep H. Gohil. | am also grateful to Mrs. Nancy Secrest, International Secretary of TOS for attending T'S-Conferences in India with our National Secretary Bro K. Sivaprasad.

Fund of TOS-In-India has increased but due to the fall of interest rate. Our income has fallen. FCRA Certificate could not be renewed. Local donations are negligible. We have to make effort to collect Fund locally.

Our International President Bro Tim Boyd, International Vice-President Dr. Deepa Padhi, International Secretary of TOS Mrs. Nancy Secrest are service minded leaders. It was an opportunity for me to work with them. My sincere thanks to all dedicated TOS workers who are actually working to minimize the suffering of others and to those workers who rushed to rescue the flood affected victims in Kerala, Odisha and West Bengal during this year.

A model school in the village Ghattokama is happy with additional four classrooms built with the support of TOS. Initially 82 children were studying up to 5th class and now it has grown up to 160 studying up to 8th class. Seven member local village community is managing the school with good reputation in the locality.

## **KARNATAKA**

### **Regional Level Activities :**

The Regional Level head quartered at Bangalore has taken the lead in organizing various charitable works during the year. The office bearers at the Regional Level has been in contact with various units located across Karnataka and been motivating them to conduct as many programs as



possible with the aim of fulfilling the objects for which the TOS was founded in 1908.

Every quarter a public lecture is followed by donations of education aid, medical assistance, scholarships to deserving students from government schools, sewing machines to women from economically weaker sections, tri cycles, walkers and other support to many deserving beneficiaries are given. To these quarterly events a person who has also been doing charitable work through different institutions is invited as the Chief Guest.

At periodic intervals financial donations and other contributions like clothes, medicines, beds, etc., received from members is accumulated and donated to a cashless hospital, FOSA Humanitarian Hospital, located on the outskirts of Bengaluru, which takes care of destitutes and abandoned old aged people and orphaned children found at railway station and other parts of the city.

Student ruled note books printed with the image of Dr. Annie Besant and also the objects of The Theosophical Society is printed in bulk to be supplied at free of cost to students in government schools and other rural schools also. In some schools along with these notebooks, writing materials and scholarships to students scoring highest marks in local language have been given. Various TOS units across Karnataka have been sourcing the student note books from the Regional office to be distributed at the rural schools in their area.

Book on the life of Dr. Annie Besant has been printed in the local language Kannada. These books have been given to participating students during programs and functions.

Dr. Annie Besant's birthday on 1st October was commemorated throughout the state by holding TOS activities like having lectures on the life and work of Dr. Annie Besant, distribution of fruits at orphanages and old age homes.

A major activity taken up this year and to be continued next year as well, is providing all possible support to people affected by floods in North Karnataka. 9. students including the disabled students.

10. DOMBIVALI LODGE OF T.S.(proposed T.O.S.group): It is reported that a team of 6 members went to a village affected by flood due to Tiware dam in Raigad district. They collected food grains and household items such as ceiling fans for affected families and handed over the help to specially appointed government officer.

## **8. REPORT of ACTIVITIES in MAHARASHTRA region (2018-19)**

### **A) PERMANENT ACTIVITIES :**

1. NEW DISHA ENGLISH PRIMARY SCHOOL (Pre-primary to Std.VII) run by T.O.S. Group ,AKOT (District : Akola) SINCE 2009 and presently supervised by the group. The School is RECOGNISED BY STATE GOVERNMENT since its inception in 2009 for its academic curriculum. Extra time is given for value education including universal prayer in English and Marathi language. Poor students from villages, especially children of farm laborers and poor farmers are encouraged to get 'quality' education. School fees is contributed by the parents in consultation with teachers (no profit-no loss principle). School materials, dresses, transportation cost is also shared with parents and some donors. Students participate in considerable co-curricular programs.
2. HONORING SOCIAL WORKERS : Every year the annual convention of Marathi Theosophical Federation takes place at different Theosophical Lodges in Maharashtra region. During this 3 days program of convention, a session of 2 hours is conducted by T.O.S., especially to promote TS-TOS relationship. T.O.S.-Maharashtra presents the work report as well as felicitates the recognized social workers, groups of individuals and institutions working in the district wherein the convocation is conducted. The social workers working in divers field of work intended for social betterment in that particular district/locality are identified. They are contacted. The information of their work is obtained and they are invited for being honored. They are awarded with souvenirs, framed-certificates, set of theosophical books and some gift articles. The local media and press generally gives publicity to this event. Since 2012, every year 12 to 16 social workers are honored by T.O.S. .

## **2. GIVING SCHOOL MATERIALS TO PRIMARY SCHOOL STUDENTS IN REMOTE AREAS/VILLAGES IN PUNE DISTRICT**

The children need to be encouraged to go to school and to get educated in their early ages. Though government provides schools and teachers in remote areas and villages but due to socio-economical situation the children are discouraged. T.O.S. Maharashtra has been putting efforts since 2010 in providing school materials to poor students of primary schools initially in 6 villages namely Malegaon, Wanjale, Watunde, Atalwadi, Padharwadi and Shedgewadi. At present, alongwith these schools four more schools are identified and poor students are being helped. School bags, Notebooks, Drawing books and crayons, Pencils, Erasers, Slates, School dresses, competitive examination books, etc. are given to students. School teachers inform T.O.S. volunteers in case of any student is in need of certain school materials. T.O.S. volunteers visit these schools, they encourage students and teachers too. Over the time, T.O.S. volunteers noticed that this activity is proved to be useful for empowering students academically, emotionally and socially. Even though the help is not enormous but the consistency in the activity exhibits profound and underrated concern for such students. The similar activity has been regularly conducted by T.O.S. groups at Akot, Malegaon, Nandurbar and Pune. Recently, Amravati group started this activity. If reported by villagers or teachers, some poor high school students are also given notebooks and other materials. Every year, 100 to 120 primary school students in remote areas are benefitted. In 2018-19, number of beneficiary students is more than 300 (till 15 August 2019). T.O.S. groups get cooperation from teachers of these primary schools. Some of the teachers become life members of T.O.S.

### **B) YEAR-WISE ACTIVITIES :**

1. **DISTRIBUTION OF SEWING MACHINES TO WOMEN IN NEED OF SUPPORT TO THEIR LIVELIHOOD :** Sewing machines are given to four women, three in Nandurbar district and one in Pune district. The fund of Rs. 20,000 was received from T.O.S.-India and almost equal fund was added to it by T.O.S.-Maharashtra. Some sewing machines were already handed over last year (during 2017-18).



2. **PARTICIPATION IN SOCIAL PROGRAMME OF THE GOVERNMENT- 'SAVE GIRL-CHILD, EDUCATE GIRL-CHILD' :** Out of the fund received from a local donor, T.O.S.-Maharashtra in collaboration with a government school at Sus village near Pune organized different co-curricular activities for girlstudents during a period of a week and the leading performers were felicitated with prizes and certificates of appreciation. The school was decorated with banners of posters mentioning importance of girl-children such as -'Save girl child, educate girl child', 'Girl child - an excellent child', etc.. A cultural programme was performed by all the students in school and the parents of students were invited to this programme. Girl-students were felicitated during this programme. Self-defence workshop was also organized for girls.
3. **PAYMENT OF THEOSOPHICAL SOCIETY'S MEMBERSHIP FEES OF FIRST YEAR OF COLLEGE STUDENTS PERFORMING EXCELLENT IN ESSAY OR DEBATE COMPETITION ORGANISED BY T.S. LODGES:** Akola Lodge Theosophical Society conducted an essay competition for College and High school students on the subjects conforming with teaching of theosophical society. Out of the participants, first five meritorious students were given the prize by T.O.S. in the form of payment of first year's membership fees of these five students in case they wished to become the member. The students do not have earning resources and also that they are hardly allowed to join the organisations by their parents for the simple reason of keeping focus on their studies. This activity can be turned to be a permanent activity of the region.
4. **CONTRIBUTED FUND FOR CONSTRUCTION OF POOR FAMILY'S BURNT HOUSE IN VILLAGE NAMED AMBEWADI NEAR BELGAUM:** An appeal was received from T.O.S. group at Belgaum for contributing some fund aimed to be used for providing construction materials to a poor family in Ambewadi village . The family had recently lost its house in burning incident. T.O.S.-Maharashtra contributed Rs. 7,000 for this generous help and handed over the fund to T.O.S. group at Belgaum for further action.
5. **ESSAY COMPETITIONS AT GROUP AND REGION LEVEL:**

In view of promoting theosophical teaching in the society one of the important activity has been initiated to be conducted on group and region level. This activity is conducted at T.O.S. group Malegaon, Akola, Amravati and Pune while other groups are preparing for it. The essays are concerned with subjects of social importance like water use literacy and environment protection and of theosophical values like universal brotherhood and importance of spiritual study. This activity is taken in collaboration with lodges of theosophical society.

**C) ANNUAL WORKSHOP conducted by the region :**

Report in brief: One day workshop was held on 13 January 2019 at Pune Lodge Theosophical Society) o 16 members from different groups were present. 4 group leaders conveyed their inability to attend meeting due to various reasons. o Out of 7 executive body members, 5 members were present. 2 members conveyed their inability to attend meeting due to their ill health. o Secretary of the region, Bro. Arun Palkrut, welcomed the members and well-wishers attending the meeting and workshop and read messages of members and group leaders who could not attend the program/meeting due to various reasons. He emphasized on coordination and spread of TOS activities in the region. He requested Bro.Sanjay Potey, President of the region, to conduct the program ahead. o The chief speaker: Bro. S.H.Vaidya, Ex-Scientist in DRDO,Govt. of India. He spoke on TS-TOS interaction. He circulated among the audience the printed notes of his speech, well focused on importance of selfless services and universal brotherhood. He cited some points on which the members can work to attain selfless services. Audience largely appreciated the speech. A question answer session was followed. o TOS Pune group demonstrated the activity of giving school materials to primary students in 7 villages in remote areas in Pune district. In this concern, two primary school teachers who have been practically involved in this activity since past 8 years were called to talk their experience to be shared with the audience. The teachers not only appreciated the work of TOS for consistently giving the school materials to the students in need but also working in such remote locations where no other organisations or groups of people come forward to help the students. Kshirsagar and Mr. Shinde, told the audience the usefulness of the work of TOS. They suggested to increase the number of beneficiary-students. o TOS Nandurbar group leader Bro. Shivdas Pawar spoke on different activities of TOS group at Nandurbar. He explained as to how the activities are identified and actual work is implemented since past 4 years. o TOS Amravati group leader , Bro. Madhukar Wankhade, expressed his views on expanding TOS work in Amravati and adopting villages which are facing acute drinking water problems. He discussed with the audience how this work can be made effective. o TOS member, Bro. Maruti Sinare, presented his work on water conservation in villages and distributed printed notes which demonstrate the actual work of water conservation in the fields. o TOS patron members, Bro. Kaustubh Bhadbhade, expressed his practical experiences in serving the people. By using the small gestures of generosity and adopting appropriate behavior with the people a lot of work can be done. He put the views of collaborating with like-minded organisations to carry out TOS activities. The coaching classes can be conducted to enhance the moral and confidence in job-seekers in different disciplines of jobs. o Certain proposals concerning TOS work were noted and discussed. o It was decided to prepare the programmes for essay and elocution competitions and enhance activities for school students belonged to poor communities/families. o Luncheon was served to the audience. o The program was concluded by Universal Prayer of TS.

# ODISHA

## Activity report of TOS, Mahabharat Group, Bhubnaeswar

### 1. Sixth Annual Conference of the TOS, Odisha Region :

- On 22nd September 2019, the sixth Annual Conference of the Odisha Region was organized in the Conference Hall of Royal College of Science and Technology, Bhubaneswar. The theme of the conference was "Transform the Self: Transform the World". Prof. Ganeshi Lal, Honourable Governor, Odisha was the Chief Guest and Sri B.L. Bhattacharya, National Director, TOS -India was the Chief Speaker. Prof. Achyuta Samant, Founder Chancellor, KIIT & KISS University was the other Guest who was felicitated with the Besant Selfless Service Award for his life time contribution to the society.
- All the guests spoke at length on the theme and suggested ways and means to live together in the society and make it a descent place to live in. Together they remarked that before changing the world it is important first to transform the self with a higher level of awareness and consciousness that would change the world in a positive way. There was a short speech on the theme and several persons like Sri Krupasindhu Mishra, Prof. RK Mishra, & Brother, Parthasarathy Sarangi participated in the discussion.

### 2. Annual conference of TOS, Eastern India :

On 10th February 2019, the annual conference of the TOS, Eastern India, was organized at the UTF Head Quarters, Bhubaneswar. Ms. Nancy Secrest, TOS International Secretary and Brother B.L. Bhattacharya, National Director, the Theosophical Order of Service in India were invited as the Chief Guest and Guest of Honour respectively.

The theme of the conference was "Giving is Living" and an essay competition was arranged on theme. Students of Sai International School participated in the competition. Ms. Nancy Secrest gave away the cash prizes to the winners - Bipasha Dutta (1st), Isha Mahakud (2nd) and Spandana Ray (3rd).

As part of a signature campaign on women empowerment, all the delegates in the conference led by Ms. Nancy Secrest signed a banner.

On 7th February 2019, Ms. Nancy Secrest visited the tailoring unit functioning at Bhimatangi. She interacted with the trainees, saw the dresses stitched by them and appreciated them for their skill set and performance of the trainees. Thereafter, she visited MahiniPramilaJaraNiwasin Jagannath Nagar area. She interacted with the old and ailing inmates and appreciated the work of the supervisor Shri RamnathNayak and encouraged him to do still better in future. Next day i.e., on 8th February, 2019, she visited the health checkup camp at "Mission Ashra" followed by a visit to the Aadruta Children Home, an orphanage, where she interacted with the children and encouraged them in their pursuit for art, music, dance and various other activities.

### **3. Women empowerment program - Education for girl children**

Every year, Mahabharat Group has been sponsoring Rs.250,000 to 25 poor but meritorious girls for pursuing higher studies from donations received from its members and other donors. This is the fourth year of assistance given to them. The programme started in 2015 as a five-year programme for helping such persons to pursue higher education.

### **4. Women empowerment program - Karate training for girls**

As part of self-defense training of girls, Karate training is being organised in different schools and also in slums.

### **5. Women empowerment program - Skill development**

- The mobile tailoring training unit of the Group functioning in the slum area of Bhubaneswar is very popular among women as many from the slum have been trained under the "women empowerment through skill development" programme. The programme was indeed a confidence booster and it enabled them to undertake gainful economic activity for augmentation of their family income.
- The mobile tailoring training unit was shifted to Bhimatangi area from February 5, 2018. Four batches have completed training and the fifth batch's training is underway at Bhimatangi. It is expected to function in the area for some more months as the response from the women in the neighborhood has been good. Brother K Sivaprasad, National Secretary, TOS in India, and Ms. Nancy Secrest, TOS International Secretary, had visited the unit during their respective visits to Bhubaneswar. We also acknowledge the financial assistance by TOS, New Zealand in

this regard.

- As part of rural outreach, the group has started an additional training facility at Haridamada Village in Mendhasaal Panchayat since August 2, 2019. The centre has been provided with five sewing machines and other tools.
- One leg-operated sewing machine was given to Ms. Satrusal and a hand-operated sewing machine was provided to Miss Tulasi Behera, who is disabled in her lower limbs, for their livelihood and self-sustenance.

#### **6. Assistance to homes for aged persons and destitutes:**

- Financial assistance of Rs.10,000 and sarees were given to inmates of Asha Kiran Home, Balisahi, Pattanaikia, a shelter for destitute and aged.
- "Mahini Pramila Jara Niwas", GGP Colony, Jagannath Nagar, Bhubaneswar, was given financial assistance of Rs.59000 for construction of the house and replacement of the electric pump for the bore well.
- On the occasion of the Raksha Bandhan, Sister B.K. Leena and the group members visited "Mission Ashalok", a home for the male destitutes. She tied the inmates with 'Rakshi' on their wrists and the group gave them bed-sheets worth Rs.11288.

#### **7. Super cyclone "FANI" and related relief:**

- After the devastating super cyclone "FANI" affected the entire coastal belt of Odisha on 3rd May 2019, many people were distressed. As a goodwill gesture, TOS International had donated Rs.100,000 for the CM's Relief Fund, which was formally donated to the Chief Minister, Odisha, in his office.
- Additional fund of Rs.202000 was also mobilized from members and other patrons for the cyclone-affected people. Out of this, Rs.50,000 each was provided to MP Old-age Home and Adruta Children Home and Rs.12,500 was given to Ms. Kanchan Das, Tailor Master, whose house roof was damaged. Rs.20,000 was given to UTF for repair of its damaged premises.
- Besides, in a health camp arranged for the pregnant women residing in 'Mayfair slum' of Bhubaneswar, a gynecologist



examined them. The relative women were given food supplement (Horlicks), medicines, etc. worth Rs.18,700. Lactogen was given to newborn babies.

- The group has earmarked Rs.100000 for adequate plantation of trees in Bhubaneswar as a large number of trees were uprooted in the city during the super cyclone. For this, it has received financial assistance of Rs.66800 from TOS in India, Varanasi and the remaining money would be spent from its own fund.
- We sincerely thank all our members, patrons and well-wishers in India and abroad who have donated generously for the relief work.

## **8. Inspiring differently abled children :**

Differently abled children from J&K, who had participated in the Anjali International Children Festival, 2018, were invited on 15th November 2018 to UTF Building in Goutam Nagar. Members of TOS, Odisha Region, interacted with them. Notwithstanding their disabilities, these children showcased their talent in singing, acting and dancing. The TOS, Odisha, members immensely enjoyed their performance and inspired the children for more such action but more importantly they themselves were greatly inspired by the indomitable spirit of the children who could overcome their handicap with sheer determination and will power and lead life of any normal child.

## **9. Health-camps and helping people for treatment of ailments / disabilities**

- A health camp was organized at "Mission Ashra" for mentally ill and destitute women on February 8, 2019. Five specialist doctors from various disciplines volunteered in the health check-up camp and medicines worth Rs.20000 were distributed. Ms. Nancy Secrest visited the camp as a guest and appreciated the work being done by the group.
- Three cancer patients were given financial assistance to the extent of Rs.30000 for procurement of medicines during the report period.
- Rs.10000 was provided to MP Old-Age Home for treatment of an inmate, Gourimausi, for her urinary infection and kidney ailment.

- Rs.20000 was given to Uma Shankar Dash for procurement of his prosthetic leg.
- Rs.10000 was given to TASWELS, ORISSA-Thalassemia Society.

### **10. Happiness in life :**

A new project has been initiated under the banner - "Happiness in Life" as in the present days many have the mental affliction called depression. The project involves, among other things, a lecture session by an eminent Psychologist, Prof.F.M.Sahoo, who is a member of TS/TOS as well. Recently, we had organized two meetings in public places like Ladies Association and Rotary Club of Bhubaneswar. He addressed the Ladies Association, consisting of 30 elderly ladies, on Geriatric depression and how to combat it and live a happy life. In Rotary club, he spoke on 'Mind management and happiness'. On both occasions, the audience appreciated the speech. Depression has now become an epidemic afflicting many among women, men, homemakers, retired persons, affluent people, middle aged, unemployed ones, overstrained students, etc.

### **Regional Level :**

I became the Regional Secretary during the course of Annual Regional Meeting held in June, 2012 at Kakinada. In our Region we have eight TOS Groups, viz. Kakinada, Pithapuram, Visakhapatnam, Tadepalligudem, Vijayawada, Kankipadu and Nellore and Rajahmundry. The present eight groups are in a working situation with limited effort at their disposal commensurate with the available resources and general constraints. I place before your good selves the service activity of the following Groups of Telugu Region for the year ending 30.09.2019. There is no activity on the Regional front.

#### **1. Kakinada TOS Group, Kakinada: East Godavari District**

1. On every Sunday we distribute to the needy free herbal medicine SARVAROGANIVARINI comprising of sixty herbs duly prepared and distributed by our Kakinada TOS Group President Er. Bro. K.V.V.Satyanarayana Murthy, (popularly known as Engineer Murthy), major portion from out of his own funds with limited resource support from TOS Group to the extent of Rs.5,000/- (annually), which works out to Rs.12,000/-per month. This medicine is distributed in our Lodge premises as well as two other places in Kakinada and also at Visakhapatnam Group on every fourth Sunday. Our Kakinada Group President made efforts to introduce this distribution at Vijayawada Group, which is not yet materialized. During the year 2018-19 an amount of Rs.5,000/- was provided as grant by the Gowthama Lodge of Theosophical Society, Kakinada to the Kakinada TOS Group to meet the expenses of this herbal medicine. Annual amount spent on this program: Rs.1,50,000/-
2. During this summer in May, 2019 service activity of distribution of butter milk packets to public on Raja Rammohan Roy Road for twenty days spending an amount of Rs.9,000/-
3. Kakinada Group of TOS can proudly inform that the benevolent charity program of an organization Chirudeepam, a Registered Society comprising likeminded employees of Reliance Industries

Limited. KGD6 Project, Kakinada in the distribution of nutritive food packs to two hundred HIV affected children of mofusil areas of Kakinada on every third Sunday of the month. This program takes place in the premises of Kakinada Theosophical Society Gowthama Lodge. The employees of this organization spend their own generated funds for this program.

**2. Ganapathi Muni TOS Group, Visakhapatnam: Visakhapatnam District**

**3. Besant TOS Group, Tadepalligudem: West Godavari District**

This Group provided during the year an amount of Rs.1,000/- to World Teacher Trust Charity Dispensary, Kankipadu.

**6. Krishnaveni TOS Group, Vijayawada: Krishna District - Charter No.85/1989**

medicine to 20 to 30 patients. This was an ongoing program since four years.

Vocational Centres(Brahmshakti Mahila Prashikshan Kendras). Total 9 Centres have been wound up on completion of the target. Two new Vocational Training Centres were started at Vill Dadri & Gamma-1. Total active Centres now are 9.

Marriage Support for Economically weaker women. A Total of 32 Sewing Machines, 5 Table Fans and 2 Electric Irons were presented. A Refrigerator was presented as a special case.

Education Support for BPL Students. School fee for 4 Students from the rural area, was sponsored, besides Books & Stationery items.

Re-construction/renovation support for semi-built Loyal School, Ismailpur Village. This School being supported from the beginning has now been finalized with cemented flooring, walls & roof and final painting of the entire School. Total financial support this year was Rs 1,50,600 (singly supported by OPG Foundation).

6. Attempt should be made to publish a souvenir and folders should be provided to the delegates, registration charges should be fixed within Rs.100-150/-, Rs.3000/- will be provided from the TOS India.

### **REGIONAL CONFERENCE GUIDELINES**

1. The Region should organize Annual General Body Meeting and Annual Conferences within September every year with a chief guest as National Director/Secretary/National Committee

member and a report to be sent to the Secretary, TOS India. If so desired the A G M and A C may be clubbed together.

2. Officers to the Region should be elected in the A G M after giving due notice to all good standing members after every three years. In case the Region fails to do so, the president of the region should suggest to the National Director the name of the person to be appointed as Regional Secretary to form a new Executive Committee for their Region.
3. The Annual report, and audited account of the Region along with the enclosures are to be sent to TOS India duly approved by the A G M.

## **GUIDELINE FOR COLLECTION OF DONATION FOR TOS WORK**

### **B. L. Bhattacharya, National Director**

Members of TOS should remember that it is not an organisation like other NGOs who also render service to minimise the suffering of others, collect money from many sources and utilise a portion of it for staff salary and other administrative cost.

TOS is a union of all who love in the service of all that suffers. It has great significance. It is a service with love and regards and without any expectation to all living beings.

TOS groups are mainly formed by TS members and its activities make the first objective of TS practical and they carry the message of TS to common people to some extent. Money and dedicated works are needed to render proper service of course, there are many ways of helping the needy without money also. Charity should begin at home.

Presidents, Secretaries of groups and regions and kind hearted members donate for the work of TOS. If the group or region is properly organised they can collect donations selectively from corporate sector and banks that provide funds for social work. For

this purpose they need to maintain and submit audited account, article of association, PAN card etc but they are not required to get the TOS group or region registered separately as TOS . India (1908) is registered under the registration of societies Act 1860.

If the donors want to avail of the benefit under 80(g) of the income Tax Act 1961 then at par cheques or drafts in favour of theosophical order of service in India payable at Varanasi to be collected and sent to National treasurer, TOS India, Varanasi to issue necessary certificate and remittance of fund to respective groups and region.

Proper project on health education sanitation, drinking water, animal welfare and environment etc should be sent along with the appeal for donations. While collecting donations, TOS groups and Region should consider the motive and honesty of the donor. The donations should be utilised only for the purpose for which it was paid.

## **The Theosophical Order of Service.**

### **An Address by Dr. Annie Besant**

THE THEOSOPHICAL ORDER OF SERVICE was founded in order that a definite line of work be done on the ground of Brotherhood used in Service, and for that reason it requires a certain number of members to be connected with the T. S.

At one time, there was an inclination to confine the work of the T.S. to Theosophical Teachings. If we use the translation of the Greek word Theosophy, Divine Wisdom, there would be no danger of the T. S. being a sect.

The T. O. S. must leave the people free to show their brotherhood, to choose their own line of work. The term "Theosophical" Order of Service emphasizes the fact that the theory of brotherhood is embraced by its members, the same as tolerance and a willingness to accept all forms of Truth. "There is no Religion higher than Truth". The brotherhood of the T. S. is a nucleus of brotherhood. The O of S is intended to help us towards the realisation of Universal Brotherhood, not merely a brotherhood of the Elder Brothers, but with the criminal classes as well. Universal Brotherhood must not be a phrase, but a principle in life.

Is the first object of the T. S. in conflict with the second and third? If we talk of Universal Brotherhood, we ought to make no distinction as to who should be admitted to the Society. I should like to include in Universal Brotherhood, not only humanity, but all animals, even plants and minerals. We have a particular cell from which all the formative powers, strength and life go out. By treating a dog kindly, his mental growth quickens. A master said: "The heart of our Brotherhood is the unselfish service of mankind." That should be the aim of every member of the O. of S., should be an active force with which every member takes up some duty of a beneficent kind. A certain no-Theosophist, who is a keen worker, asked for a group in favour of vivisection to be formed in the O. of S. as a group for anti-vivisection already existed. I told her that, if she could show that torture of animals was consistent with brotherhood, I should agree. I never heard of the matter again.

Let us not fear to go among the lowest; for the purer the person, the more can he move in perfect safety, even among the most "Vile". When Shri Rama, the perfect king, was approached by a woman of bad reputation, he accepted the gift she offered and ate the fruit she had bitten into. And

the Christ, when giving back health to the diseased, told them to “sin no more”, to live the perfect life, the seed of which is in everyone and everything. There is only one Divine Life, and all life is part of Him. “Shall there be evil in a city, the Lord hath done it.” “If I go up into Heaven, Thou art there, if I go down into Hell, Thou art there also.” Reverence the Divine Life in everything; recognize that good and evil are experiences. The more experiences we have, the better we evolve. A “mistake” as Mr. Ford once said, is but what adds to our knowledge. We should of right or wrong by the person who does it; thus we shall know whether it was done willfully or as a mistake. As imperfect beings, we cannot do perfect work, but we can realise that gaining an experience is the only way to progress.

Consider a discovery such as that of Galvani, the great investigator, who found the action of Galvanism through his observation of the moving frogs’ leg hung on his balcony. Let his friends call him the “Frogs’ dancing master”; he knew he had discovered a hitherto unknown law in nature. Thus our knowledge is ever increased. The Galvanometer, when put on the head of a person thinking hard, answers by swinging. By looking into the unknown we progress.

If we take Theosophical thought as the key in our studies, we realize that God exists everywhere, that He who is Supreme Goodness, is also Supreme Law. Our understanding increases with our learning: “Give me understanding and I shall keep your Law, yeh, I shall keep it with my whole heart.”

Reincarnation is the key to the world. The more we study Theosophy the more will the puzzles of the world become clear.

In the O. of S. you have the key to an orderly life. Choose your activity carefully. In the morning make a plan of your day’s work; use your thought power beneficially; make the habit (till it comes naturally) of snatching every opportunity to help and you will find thousands of things come in your way.

Do not get discouraged if your progress is but slow. I used to have a hasty temper, it took me years to get over it. I was helped by a lesson I got. I once saw a cartman striking the horse on the nose; I spoke to him heatedly and got a bad reply. Then I puzzled out that he was irritable only as I had been! I realized that in order to be truly useful, we must not stoop down, but must place ourselves beside those we want to help.

Try to bring into your Lodges people with whom you utterly disagree, and try to grasp their line of thought. The Law of Love, the only great law, will help you to understand the others; your knowledge will help you to bring the ignorant out of their ignorance and so to grow more quickly in evolution.
